The voting and dispositive control over these shares is shared by certain members of KPCB XIII, none of whom has veto power. Excludes 411,004 shares in the aggregate beneficially owned by individuals and entities associated with KPCB XIII and held for convenience in the name of "KPCB Holdings, Inc. as nominee," for the accounts of such individuals and entities each of whom exercise their own voting and dispositive control over such shares.

The reporting persons disclaim beneficial ownership of these shares except to the extent of any pecuniary interest therein, and the filing of this report is not an admission that the reporting persons are the beneficial owners of these shares for purposes of Section 16 or for any other purpose.
