This Amendment No. 1 (this "Amendment") relates to the Statement of Beneficial Ownership on Schedule 13D filed with respect to the common stock, \$0.0001 par value (the "Common Stock"), of RPX Corporation (the "Issuer"), which was originally filed on June 26, 2018 (this "Schedule 13D"). Unless otherwise indicated, all capitalized terms used herein but not defined herein shall have the same meanings as set forth in the Schedule 13D.

#### **ITEM 4. PURPOSE OF TRANSACTION**

Item 4 of this Schedule 13D is amended and supplemented by the addition of the following:

Pursuant to the Agreement and Plan of Merger, dated April 30, 2018 (the "Merger Agreement"), by Riptide Purchaser, Inc. ("Purchaser"), a wholly owned subsidiary of Riptide Parent, LLC, ("Parent"), to purchase all of the outstanding shares of common stock, par value \$0.0001 per share (the "RPX Shares"), of RPX Corporation ("RPX"), on June 19, 2018, the Reporting Persons tendered all of the shares of Common Stock beneficially owned by them as reported on this Schedule 13D and such shares were accepted by the Offeror on June 19, 2018.

#### **ITEM 5. INTEREST IN SECURITIES OF THE ISSUER**

Item 5 of this Schedule 13D is amended and supplemented as follows:

- (a) As a result of the Tender Offer, the Reporting Persons no longer have any beneficial ownership in the Common Stock.
- (c) The disclosure contained in Item 4 of this Amendment is incorporated herein by reference.
- (e) The Reporting Persons ceased to be beneficial owners of 5% or more of the Issuer's Common Stock on June 19, 2018.
